## **SHOW CONDITIONS**

- \* This show is an NRHA approved show and will adhere to all NRHA rules , unless noted.
- \* All dogs must be on a leash and are not permitted in the arena or concession area city and county ordinances.
- \* Stalls will be available April 3, 2024 at 8:00 am. Please contact IRHA Show Management for any early arrival. No stalls will be opened without prior notification.
- \* School Classes Start Time 8:00 am. 6 minute time limit 30 seconds to enter & 30 seconds to exit 5 minute schooling. Entry Fee \$35.00. Please be kind & courteous of your fellow exhibitors. There will be no payouts or awards.
- \* Show Tabs will be put in the name of the responsible party as listed on the entry form. A form of payment must accompany each show tab from the person listed as the responsible party, in the form of; cash, check (personal or business) or credit card. An IRHA service fee of \$35.00 and any bank fees will be applied to all return checks. If return check (s) are not made good with in 10 days, all informations will be turned over to NRHA for collection and disciplinary procedures. A 3.5% service charge will be applied to all credit card payments.

- \* Payout checks will be mailed once management receives NRHA approval of results. Payout checks will be mailed 30 days after the last day of the show. If checks are mailed out prior to NRHA show approval results IRHA and Show Management will not be held liable for any prize money or awards not returned to Show Management by those who are disqualified by NRHA. Those who fail to provide payment for outstanding invoices or return disqualified prize money with in 10 days of being notified will be suspended from any further IRHA events and reported to NRHA for disciplinary procedures.
- \* Class entries will not be accepted for NRHA classes, without a current NRHA membership and competition license, for both owner and rider. NRHA memberships can be renewed at the show.
- \* Per NRHA rules: Section F. General Show Conditions. #6 Exhibitors that enter and scratch a class for any reason after the class has been posted will be liable for any and all fees incurred in the connection to entering the class.
- \* All class entries will close ay 6:00 pm. Draws will be posted by 7:00 pm or after. Entries will still be accepted after the class is closed, however late entries will go first or last depending on show management decision.

  Online entries will not be accepted after March 27, 2024.
- \* Class drags are determined pursuant to NRHA rules and as determined by show management. No drag changes will be made after the class draws are finalized.
- \* IRHA Show Management & IRHA Board of Directors have the right to cancel, combine and/or adjust show schedule as needed.
- \* Damage Individuals will be responsible for any physical damage inflicted to the facility property and will reimburse the show management for such damage as it may be charged. All owners and exhibitors shall be responsible for any damaged incurred by them, their agent or employees to stalls, buildings and other properties on the show grounds and shall be billed accordingly. Stalls and grounds must be left as you found them.
- \* Liability By participating in an IRHA event, all competitors agree to abide by the rules of the show and the governing body of NRHA. In Addition, acknowledge that a horses are dangerous animals and can be hazardous. By participating in the competition with this knowledge of the danger

- involved the competitor agrees to accept any and all risks of injury or death.
- \* Behavior, Conduct, and Animal Welfare Any action of disrespect, deceit or fraud directed to show management, grounds crew, show management and/or representative or judges will realist in disqualification from competitive and removal from facility. No fees, entry or stall refunds will be refundable. Individuals accused of unsportsmanlike conduct will be subject to the disciplinary procedures set forth by the National Reining Horse Association on Article A of the handbook and will be suspended from IRHA events for a term determined by show management. NO ABUSE TO ANIMAL WILL BE TOLERATED. Stabling and arenas will be monitored 24 hours a day. Anyone found to be abusing animals will be disqualified and reported to NRHA.
